4-4-2: RESTRICTIONS:

No licensee hereunder shall unnecessarily annoy or antagonize anyone, or force himself upon any citizen by operating under this license.

No operator or licensee hereunder shall enter any private dwelling, apartment or room in the city without having obtained advance permission of the owner or occupant thereof. (Ord. 1369, 4-5-1948)

4-4-5: ISSUANCE OF LICENSE:

A. Any person who has filled out the application required by this chapter and met all the other terms and provisions of this chapter, shall be issued a license hereunder by the director of finance.

B. No person shall be issued a license hereunder if the following circumstances apply:

1. Said person has not fully complied with the terms of this chapter.
2. Said person has furnished false information on the application required hereunder.
3. Said person has been denied a peddler's license by any other city or has had such peddler's license revoked by any other city.
4. Said person has been convicted of a crime of violence, theft, burglary, or deceptive business practices.

C. Any such license issued hereunder shall be nontransferable. (Ord. 2431, 4-6-1987)

4-4-6: LICENSE TO BE DISPLAYED:

Every such peddler, solicitor or hawker doing business under the provisions of this chapter must, upon the demand of any citizen of the city or police officer, exhibit his license. (Ord. 1369, 4-5-1948)

4-4-7: PENALTY:

- A. Any person who is convicted of a violation of this chapter may be punished, upon conviction, by a fine not to exceed three hundred dollars (\$300.00) or by imprisonment in the county jail for a term not to exceed ninety (90) days, or by both such fine and imprisonment.
- B. In addition to any other penalty herein prescribed, the director of finance may revoke the license of any person who has violated the terms of this chapter. (Ord. 2431, 4-6-1987)
