AN ORDINANCE AMENDING CHAPTER 3 OF TITLE 3 OF THE HELENA CITY CODE (ELECTRICAL CODE)

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF HELENA,
MONTANA:

Chapter 3 of Title 3 of the Helena City Code is hereby amended

- C. NEC article 550.33(A): Add the following language: "It is permissible to feed a manufactured (mobile) home with type SER cable when the service equipment is mounted on the exterior of the home. Physical protection of the cable is required by enclosing the cable in an approved raceway where the cable is run on the outside of the home. The cable is to be properly supported and attached per article 338 where installed under the home.
