ORDINANCE NO. 3207

AN ORDINANCE AMENDING CITY OF HELENA ORDINANCE No. 2359 AND AMENDING THE OFFICIAL ZONING MAP FOR THE CITY OF HELENA FOR A ZONE CHANGE FOR 2 LOTS LOCATED IN THE CLM (COMMERCIAL LIGHT MANUFACTURING) DISTRICT AND FOR 31 LOTS LOCATED IN THE B-1 (NEIGHBORHOOD BUSINESS) DISTRICT TO A B-2 (GENERAL COMMERCIAL) DISTRICT, FOR LOTS 1-33, THE VACATED ALLEY, AND THE ADJACENT VACATED COOKE STREET RIGHT-OF-WAY, ALL IN BLOCK 5 OF THE NORTHERN PACIFIC ADDITION, IN THE CITY OF HELENA, MONTANA

WHEREAS, the Helena City Commission has determined that Ordinance No. 2359 should be amended and the zoning designation of those lots owned by **Montana Business Assistance Connection (MBAC) and Russell & Denise Wolf**, and legally described as Lots 1-33, the vacated alley, and the adjacent vacated Cooke Street right-of-way, all in Block 5 of the Northern Pacific Addition, as shown on Certificate of Survey No. 502954/T, in the City of Helena, Montana, should be changed as follows:

Two lots from CLM (Commercial Light Manufacturing) and 31 lots from B-1 (Neighborhood Business) to B-2 (General Commercial), as shown on Exhibit "A" attached hereto

WHEREAS, the official zoning map of the City of Helena, Montana, as noted in Section 11-1-3 of the Helena City Code, should be amended to change the zoning designation for said property; and

WHEREAS, a public hearing was held on **March 10, 2015**, before the Helena Zoning Commission concerning said amendment of Ordinance

No. 2359 and said rezoning, and the Zoning Commission recommended **APPROVAL** of the amendment and zone change; and

WHEREAS, a public hearing was held on **April 20, 2015**, before the Helena City Commission concerning amendment of Ordinance No. 2359 and said rezoning at which staff recommended **APPROVAL** of the amendment and zone change; and

WHEREAS, said amendment and zone change appear to be in the best interests of the City of Helena, Montana, and the inhabitants thereof; and

WHEREAS, in considering said amendment and zone change, the City of Helena has given due consideration to the matters set forth in §76-2-304, MCA.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. City of Helena Ordinance No. 2359 is amended and the zoning designation of the property legally described as Lots 1-33, the vacated alley, and the adjacent vacated Cooke Street right-of-way, all in Block 5 of the Northern Pacific Addition, as shown on Certificate of Survey No. 502954/T in the City of Helena, Montana, generally located as stated above, is changed as follows:
