**A RESOLUTION ESTABLISHING FEES TO BE CHARGED FOR THE  
LAST CHANCE SPLASH WATER PARK AND POOL**

**WHEREAS**, based on evaluation of operational programming, hours of operation, and fee options that were instituted for the 2010 season, there are no recommended changes to the fee schedule or programs; and

**WHEREAS**, a public hearing was held on the proposed fees on **February 28, 2011, at 6:00 p.m.** in the Commission Chambers in the City-County Building at 316 North Park Avenue in Helena, Montana.

## **Resol. No. 19815**

Punch Passes are transferrable and are valid for 10 visits per season. Unused punches on punch cards will not be extended to the next season. No refunds will be given for lost or stolen punch cards.

Season Passes are non-transferable and good for unlimited visits during one swim season. Lost season passes may be replaced with proof of purchase.

**Section 2.** The following definitions apply for purposes of this resolution only:

"Adult" is a person 13 to 64 years of age.

"Resident" is any person who resides within the city limits of the City of Helena.

"Non-resident" is any person who does not reside within the city limits of the City of Helena.

"Senior" is a person 65 years of age or older.
