## **RESOLUTION NO. 20088**

### **A RESOLUTION DECLARING TANGIBLE PERSONAL PROPERTY OWNED BY THE CITY OF HELENA TO BE SURPLUS PROPERTY AND AUTHORIZING THE DISPOSAL OF THAT PROPERTY**

**WHEREAS**, the City of Helena owns eight (8) Aimpoint electronic rifle sights that were formerly used with its police patrol carbines; and

**WHEREAS**, the City of Helena is separately transferring ten (10) military surplus rifles to the Montana Department of Justice Gambling Control Division as part of a governmental surplus program; and

**WHEREAS**, the Montana Department of Justice Gambling Control Division has requested that the City of Helena donate the Aimpoint sights to the Division when it separately receives the military surplus rifles from the City; and

**WHEREAS**, the Aimpoint sights are no longer needed for use by the City of Helena at present or in the foreseeable future; and

**WHEREAS**, Section 1-4-28 of the Helena City Code identifies both intergovernmental cooperation and transfer to another government agency at or below market value as possible considerations and means for disposition of surplus personal

property; and

**WHEREAS**, it appears to be in the best interests of the City of Helena and its inhabitants that the Aimpoint sights be declared surplus and disposed of by the City Manager through a transfer to the Montana Department of Justice Gambling Control Division.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 1.** The eight (8) used Aimpoint electronic rifle sights described on the attached Exhibit "A" are hereby declared surplus property, and the City Manager is authorized to dispose of them as allowed in Section 1-4-18(C)(3) of the Helena City Code by transferring them to the Montana Department of Justice Gambling Control Division.
