ORDINANCE NO. 3136

AN ORDINANCE AMENDING CHAPTER 5 OF TITLE 3 OF THE HELENA CITY CODE (GAS CODE)

BE IT ORDAINED BY THE COMMISSION OF THE CITY OF HELENA,
MONTANA:

Chapter 5 of Title 3 of the Helena City Code is hereby amended
as follows:

GAS CODE

- 3-5-2: Inspector
- 3-5-3: License And Bond Required For Gas Fitters
- 3-5-4: Gas Piping And Appliances To Be Inspected
- 3-5-5: Gas Installations To Conform To Good Practice
- 3-5-6: Unsafe Conditions
- 3-5-7: Dispute Between Gas Utility And Consumer
- 3-5-8: Violations; Penalty

3-5-1: ADOPTION; APPLICATION: The ~~2006~~ 2009 edition of the International Fuel Gas Code is hereby adopted and made a part hereof by reference. A copy of this code may be obtained by interested persons calling on the clerk of the commission. The provisions of this chapter apply to all installations, extensions, additions, alterations, maintenance and repairs of gas piping, equipment and appliances on a consumer's premises from the outlet of the utility's gas meter.

- A. Section 102.8, Referenced Codes and Standards, is modified by adding the following: "Any reference to a separate specialty building regulation, by title, either in this subsection or elsewhere in this code, shall be considered deleted and replaced with the title of the model code adopted by the City and in effect at the time."
- B. As specified in §76-2-412(3), Montana Code Annotated, fuel gas codes that are not applicable to residential occupancies may not be applied to a community residential facility serving 8 or fewer persons or to a daycare home serving 12 or fewer children.
