

# **RESOLUTIONS OF THE CITY OF HELENA, MONTANA**

## **RESOLUTION NO. 19752**

### **A RESOLUTION OF INTENTION TO LEVY AN ASSESSMENT UPON ALL PROPERTY IN SPECIAL STREET LIGHTING DISTRICTS TO DEFRAY THE COST OF INSTALLING AND MAINTAINING IMPROVEMENTS IN SAID DISTRICTS FOR FISCAL YEAR 2011**

**WHEREAS**, the City Commission of the City of Helena, Montana, has created Special Improvement Districts for the purpose of providing lighting; and

**WHEREAS**, the property in said Special Street Lighting Districts is to be assessed to defray the cost of installing and maintaining the said improvements, each lot or parcel of land in each district to be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, and public places.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 1.** That it is the intention of the City of Helena to pass the following resolution levying an assessment upon all property in the Special Street Lighting Districts to defray the cost of installing and maintaining said improvements for fiscal year 2011.

**Section 2.** The fiscal year 2011 assessment rates for the Special Street Lighting Districts upon all property in said districts as follows:
