## RESOLUTION NO. 19831

### A RESOLUTION OF INTENTION TO SET FEES CHARGED FOR DISPOSAL OF GARBAGE AND REFUSE AT THE CITY OF HELENA TRANSFER STATION FOR FISCAL YEAR 2012

**WHEREAS**, the City of Helena operates the “Transfer Station” which is used for the disposal of garbage and refuse and the collection of recyclable materials and diverted materials; and

**WHEREAS**, the City needs to recover the costs of doing business in both its transfer station and recycling operations, as well as the tipping fee charged by the County for use of the landfill; and

**WHEREAS**, the City is authorized to establish such rates as may be necessary to operate its facilities to insure a positive cash flow, as well as provide bond coverage requirements; and

**WHEREAS**, it appears to be in the best interests of the City of Helena and the inhabitants thereof that the Helena City Commission set appropriate fees to be charged for use of the Transfer Station.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 1.** That it is the intention of the Helena City Commission to adopt the following transfer station fees for fiscal year 2012:

**A.** The following tipping fees apply to all Transfer Station customers except City of Helena Commercial collection customers, including but not limited to, City of Helena Residential, Scratchgravel, and the City of East Helena:
