RESOLUTION NO. 19997

A RESOLUTION DECLARING TANGIBLE PERSONAL PROPERTY OWNED BY THE CITY OF HELENA TO BE SURPLUS PROPERTY AND AUTHORIZING THE DISPOSAL OF THAT PROPERTY

WHEREAS, the City of Helena owns eighteen (18) rifles previously used by the Helena Police Department; and

WHEREAS, these items are no longer needed for use by the City of Helena at present or in the foreseeable future; and

WHEREAS, it appears to be in the best interests of the City of Helena and the inhabitants thereof that said rifles be declared surplus and disposed of by the City Manager.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. The eighteen (18) used rifles described on Exhibit "A" attached hereto are hereby declared surplus property, and the City Manager is authorized to dispose of them as allowed in Section 1-4-18 of the Helena City Code.
