RESOLUTION NO. 20312

A RESOLUTION OF INTENTION TO CHANGE THE NAME OF A PORTION OF LEARNING STREET NORTH OF WEST LYNDALE AVENUE TO HUNTHAUSEN WAY AND HENRY STREET TO BISHOP CARROLL DRIVE IN THE CITY OF HELENA

WHEREAS, pursuant to §7-14-4112, MCA, the City Commission may change the name or number of any street within the City limits; and

WHEREAS, Learning Street intersects with West Lyndale Avenue to the south of the Carroll College campus, and an unnamed private street runs through the college campus, creating problems for police and other emergency vehicles; and

WHEREAS, Learning Street was previous known as Getchell Street and renamed Learning Street pursuant to Resolution No. 19747, adopted on July 12, 2010; and

WHEREAS, Henry Street intersects with Learning Street and continues east until it turns into a private access easement as depicted on Certificate of Survey No. 593697; and

WHEREAS, Hunthausen Avenue, which is a private drive, connects to Learning Street, and changing the name of a portion of Learning Street north of West Lyndale Avenue to Hunthausen Avenue and Henry Street to Bishop Carroll Drive will consolidate the multiple names of the two routes through the Carroll College

campus, facilitate notification of staff and students for E-911 purposes and reverse E-911, including cell phones, and cut down on emergency response times; and

WHEREAS, it appears to be in the best interests of the City of Helena and its citizens that said street name changes be approved.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. It is the intention of the City Commission that a portion of Learning Street north of West Lyndale Avenue on the Carroll College campus be changed to Hunthausen Way and Henry Street east of Learning Street be changed to Bishop Carroll Drive, as shown on Exhibit "A" attached here.

Section 2. An amended plat shall be prepared and filed with the Lewis and Clark County Clerk and Recorder showing the street name changes.

Section 3. A public hearing on this matter will be held at **6:00 p.m. on the 28th day of November, 2016**, before the Helena City Commission in the Commission Chambers in the City-County Building, 316 North Park Avenue, in Helena, Montana, so that all
