RESOLUTION NO. 20317

A RESOLUTION OF INTENTION TO ANNEX CONTIGUOUS GOVERNMENT PROPERTY, BEING PORTIONS OF GRANITE AVENUE, CANNON STREET, AND HIAWATHA STREET RIGHT-OF-WAYS INTO THE CITY OF HELENA, MONTANA

WHEREAS, pursuant to §7-2-4401 through 4421, MCA, the City of Helena may annex contiguous government property into the city limits; and

WHEREAS, the City of Helena desires to annex the following-described properties under the provisions of Montana law:

The full width of that portion of the Granite Avenue right-of-way from the existing city boundary line along Knight Street, extending south to the existing city boundary line along Stuart Street, and from the existing city boundary at Flowerree Street south to the existing city boundary at Woodward Avenue (Exhibit A). This right-of-way is adjacent to the existing city limits and to Blocks 305, 306, 311, and 312 of the Bellevue Addition, and Blocks 11 and 12 of the Highland Park Addition.

The full width of that portion of the Cannon Street right-of-way west of Hiawatha Street to the existing city boundary and the full width of that portion of the Hiawatha Street right-of-way north to the existing city boundary along Euclid Avenue (Exhibit B). These rights-of-way are adjacent to the existing city limits and to Blocks 191, 195, 196, 202, 203, and 206 of the Ames Addition.

WHEREAS, the City received Resolution #2016-55 from Lewis and Clark County, approving annexation of the subject rights-of-way.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA, AS FOLLOWS:

Section 1. It is the intention of the City Commission to annex the rights-of-way described above, shown on the Vicinity Maps attached hereto, into the City of Helena.

Section 2. The Clerk of the Commission shall publish notice of this Resolution of Intention in accordance with '7-2-4405, MCA, and interested parties will be allowed twenty (20) days after the first publication to submit written expressions of approval or disapproval.

Section 3. A public hearing on this Resolution of Intention will be held on the **19th day of December, 2016, at 6:00 p.m.** in the Commission Chambers at 316 North Park Avenue, Helena, Montana, at which time the Commission will hear objections to the final adoption of this resolution.
