Prior to your pick up, the HATS computer notification module will call you, making you aware of your bus arrival. We will pick you up at your curb* and deliver you within our service area. All transit buses are equipped with ADA specified wheel chair lifts. Next day notice is necessary to provide efficiency and coordination in scheduling rides. Same day with no advance notice rides will be subject to availability of seating. We accept cancellations by calling our office and leaving a message. We do provide an answering machine for afterhours cancellations.

Operating hours: Monday through Friday 6:30 AM to 5:30 PM. No buses are available on State and Federal holidays

*Origin to destination service is available upon request.

**HELENA TRANSIT FIXED
ROUTE CHECK POINT BUS**

This is a designated route bus service. We have 20 timed bus stops located in high demand areas for your convenience. No call in is required for this service. Refer to the Checkpoint bus stop list and be at one of the 20 stops for a bus pick up at the time. This bus cannot be re-routed and no deviations are allowed.

Please be aware of the 10-minute window time at all bus stop locations.

Please do not call to check on the bus location.

Operating hours: Monday through Friday 7:00 AM to 6:00 PM. No buses are available on State and Federal holidays.


