ORDINANCE NO. 3174

AN ORDINANCE AMENDING THE OFFICIAL ZONING MAP FOR THE CITY OF HELENA FOR LOTS IN BLOCK 9 IN THE BEATTIE ADDITION IN THE CITY OF HELENA, MONTANA

WHEREAS, the Helena City Commission has determined that the zoning designation of those lots owned by William H. Simons, Robert D. Sturdevant, and William J. Hasquet, and Richard and Beverly Marlow, and legally described as the west 50 feet of Lot 71B, Lot 72A, the west 28 feet of Lot 73, and Lot 74, all in Block 9 in the Beattie Addition in the City of Helena, Montana, generally located east of Dakota Street and north of the alley in Block 9, with property addresses of 1101, 1107, and 1111 11th Avenue, should be changed as follows:

From R-3 (Residential) to B-2 (General Commercial), as shown on Exhibit "A" attached hereto

WHEREAS, the official zoning map of the City of Helena, Montana, as noted in Section 11-1-3 of the Helena City Code, should be amended to change the zoning designation for said property; and

WHEREAS, a public hearing was held on February 12, 2013, before the Helena Zoning Commission concerning said rezoning, and the Zoning Commission recommended APPROVAL of the zone change; and

WHEREAS, a public hearing was held on March 11, 2013, before the Helena City Commission concerning said rezoning at which staff recommended APPROVAL of the zone change; and

WHEREAS, said zone change appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof; and

WHEREAS, in considering said zone change, the City of Helena has given due consideration to the matters set forth in \$76-2-304, MCA.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. The zoning designation of the property legally described as the west 50 feet of Lot 71B, Lot 72A, the west 28 feet of Lot 73, and Lot 74, all in Block 9 in the Beattie Addition in the City of Helena, Montana, generally located as stated above, is changed as follows:

From R-3 (Residential) to B-2 (General Commercial)

Section 2. The official zoning map of the City of Helena,
Montana, is hereby modified to reflect the changes made herein.
