RESOLUTION NO. 19830

**A RESOLUTION ANNEXING CONTIGUOUS GOVERNMENT
PROPERTY, BEING PORTIONS OF THE WOODWARD AVENUE, COONEY DRIVE,
BLAINE STREET, BILLINGS AVENUE, AND 20th STREET RIGHTS-OF-WAY
IN LEWIS AND CLARK COUNTY, MONTANA
INTO THE CITY OF HELENA, MONTANA**

WHEREAS, pursuant to §§7-2-4401 through 4421, MCA, the City of Helena may annex contiguous government property into the city limits; and

WHEREAS, the City of Helena desires to annex the following described property, which is adjacent to the Helena city limits, under the provisions of Montana law:

- 1.** The full width of the Woodward Avenue right-of-way from the existing city boundary line along Silverette Street and extending approximately 300 feet westward to the existing city boundary line along Granite Avenue, adjacent to Lots A and B-2 in Block 12 and Lots A-1 and B in Block 13 of the Highland Park Addition in the City of Helena, Montana, generally located west of Silverette Street and east of Granite Avenue and adjacent to the Helena city limits.

2. The full width of the Cooney Drive right-of-way between the existing city boundary lines located along Custer Avenue, extending approximately 1,290 feet north to the existing city boundary approximately 135 feet north of Barney Street, adjacent to Block 3 and Block 4 of the Barney Subdivision First Addition and adjacent to Block 1 and Block 6 of the Barney Subdivision Second Addition, generally located north of Custer Avenue and adjacent to the Helena city limits.

3. The full width of the Blaine Street right-of-way extending approximately 170 feet north of the existing city boundary along the frontage of Lot 9 in Block 3 of the Hewins Addition, and the full width of the Blaine Street right-of-way extending south of the existing city boundary from the intersection of Blaine Street and Billings Avenue, adjacent to Blocks 15, 16, 21, and 22 in the Boyce Addition, generally located north and south of Billings Avenue and adjacent to the Helena city limits.

4. The full width of the Billings Avenue right-of-way from the existing city boundary at the intersection of Blaine Street and Billings Avenue, extending west approximately 120 feet, adjacent to Lot 9 in Block 3 of the Hewins Addition, generally located west of Blaine Street and adjacent to the Helena city limits.

5. The full width of the 20th Street right-of-way extending approximately 200 feet south from the northern boundary of vacated Butte Avenue, adjacent to the north half of Blocks 28 and 29 in the Boyce Addition, generally located north of US Highway 12 and adjacent to the Helena city limits.

WHEREAS, a public hearing was held on this matter at **6:00 p.m.**

on the 23rd **day of May, 2011**, in the Commission Chambers at 316 North Park Avenue, Helena, Montana.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA, AS FOLLOWS:

Section 1. The City Commission hereby annexes the contiguous government property described above, shown on Exhibit "A" attached hereto, into the City of Helena.

Section 2. The boundaries of the City of Helena are extended to include the property described above.

Section 3. The Clerk of the Commission shall certify, under seal of the City of Helena, this Resolution which shall be filed with the Clerk and Recorder of Lewis and Clark County, and thereafter said annexed property shall be a part of the City of Helena and the City of Helena shall thereafter have the power to pass all necessary ordinances pertaining thereto.
