RESOLUTION NO. 19918

A RESOLUTION OF INTENTION TO ESTABLISH RATES AND CHARGES FOR COMMERCIAL COLLECTION AND DISPOSAL OF GARBAGE AND REFUSE IN THE CITY OF HELENA, MONTANA

WHEREAS, pursuant to the Helena City Code, charges may be established for collection and disposal of garbage generated by commercial users in the City of Helena; and

WHEREAS, these rates and charges are necessary for the purpose of on-going operation and maintenance, and the capital purchase of equipment; and

WHEREAS, the City Commission desires to clarify and alter rates and charges for collection and disposal of solid waste generated by commercial users; and

WHEREAS, it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof, that the rates and charges for collection and disposal of commercial garbage be established, with an effective date of July 1, 2012.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. It is the intention of the City Commission to consider the various rates and charges for commercial collection and disposal of garbage and refuse in the City of Helena and establish rates and charges as shown on the attached **Exhibit "A"** with an effective date of July 1, 2012.

Section 2. The cost of collecting and disposing of garbage and refuse for commercial users in the City must be paid by the commercial customers receiving garbage and refuse collection and disposal service.

RATES

The following types and classes of property as defined in Title

6, Chapter 1, Helena City Code, must pay for commercial sanitation service:

- A.** Class II - Residential structures having more than four (4) units in one structure;
- B.** Class III - Mobile home parks; and
- C.** Business, industrial and commercial structures.

Section 3. A public hearing will be held on the **18th day of June, 2012, at 6:00 p.m.** in the City Commission Chambers in the City-County Building at 316 North Park Avenue in Helena, Montana, at which time the Commission will hear objections to the final adoption of this resolution.

Section 4. The City Clerk is hereby authorized and directed to cause to be published in the Independent Record, the official newspaper of the City of Helena, a notice of the passage of this resolution at said time and place, when and where this resolution will come up for hearing of objections and final adoption, and stating that said resolution is on file in the City Clerk's office for inspection.
