

RESOLUTIONS OF THE CITY OF HELENA, MONTANA

RESOLUTION NO. 19930

A RESOLUTION OF INTENTION TO LEVY AND ASSESS A TAX UPON ALL PROPERTY IN SPECIAL WATER, SEWER, AND PAVING IMPROVEMENT DISTRICTS TO DEFRAY THE COST OF MAINTAINING IMPROVEMENTS IN SAID SPECIAL IMPROVEMENT DISTRICTS FOR FISCAL YEAR 2013.

WHEREAS, the City Commission of the City of Helena, Montana, has created various Special Improvement Districts for the purpose of providing water, sewer, and paving improvements; and

WHEREAS, the lots or parcels of land in said Special Water, Sewer, and Paving Improvement Districts are to be assessed to defray the cost of maintaining the said improvements, each lot or parcel of land in each district is to be assessed for that part of the whole cost which its area bears to the entire district, exclusive of streets, alleys and public places; and

WHEREAS, a list of all lots or parcels of land assessed, with the name of the owner thereof if known, description of the lots or parcels of land and the amount levied thereon set opposite, is maintained by the Department of Administrative Services for the City of Helena.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. It is the intention of the City Commission to finally adopt a resolution levying and assessing a tax upon all lots or parcels of land in the Special Water, Sewer, and Paving Improvement Districts to defray the cost of maintaining said services for fiscal year 2013.

Section 2. The lots or parcels of land to be assessed are those shown on the list of all lots or parcels of land maintained by the Department of Administrative Services for the City of Helena. The list includes the description of the lots or parcels of land, the name of the owner, if known, and the amount levied thereon. The lots or parcels of land to be assessed do not include cemetery lands owned by associations. The assessable lots or parcels of land are all such other lots or parcels of land inside the City limits.

Section 3. To defray the cost of making improvements in Special Water, Sewer, and Paving Improvement Districts for fiscal year 2013, there be, and there hereby is, levied and assessed a tax upon all property in said districts as follows:

Section 4. That the Commission of the City of Helena, Montana, will be in session in the Commission Chambers at the City-County Administration Building, 316 N. Park Ave., Helena, MT, on the 20th day of August, 2012, at 6:00 p.m., for a public hearing at which time and place the said Commission will hear objections to the final adoption of a resolution levying the assessments.

Section 5. That notice of the passage of this Resolution of Intention shall be given by publishing as required in §7-12-4106 MCA. The City Clerk is authorized and directed to make publication of this Resolution of Intention in the Independent Record, the official newspaper of the City of Helena.
