A RESOLUTION AUTHORIZING THE EXCHANGE OF A PORTION OF MOUNT HELENA CITY PARK PROPERTY OWNED BY THE CITY OF HELENA WITH THE OWNERS OF LOTS 1 AND 2 IN THE IRVING MINOR SUBDIVISION IN THE CITY OF HELENA, MONTANA

WHEREAS, Section 1-4-17 of the Helena City Code provides that the City Commission may sell, dispose or lease real property owned by the City; and

WHEREAS, the City of Helena owns that real property, as part of Mount Helena City Park, more particularly described below:

The NW1/4NW1/4, the SW1/4SW1/4, the SE1/4SE1/4, the NE1/4SW1/4, the SW1/4SE1/4, and the NW1/4SE1/4, all in Section 25, Township 10 North, Range 4 West, in Lewis and Clark County, Montana, Geocode 05-1888-25-4-01-01-0000

WHEREAS, the City has no need for a 396-square foot portion of the above mentioned property, located in the S1/2SE1/4 that is adjacent to the northwest corner of Lot 1 in the Irving Minor Subdivision as shown on Certificate of Survey Number 3128575; and

WHEREAS, Michael L. Gilleran and Amy D. Barrett, owners of Lot 1 in the Irving Minor Subdivision, and Brenda K. Elias and Brent A. Thompson, owners of Lot 2 in the Irving Minor Subdivision, desire to convey a 2.78-foot wide strip of their property along the southern boundary of both lots to the City of Helena in exchange for the abovementioned Mount Helena City Park property being conveyed to the owners of Lot 1; and

WHEREAS, it appears to be in the best interests of the City of Helena and the inhabitants thereof that the 396-square foot triangle shown on the Amended Plat of the Irving Minor Subdivision attached hereto and by this reference made a part hereof, be conveyed to Michael L. Gilleran and Amy D. Barrett, owners of Lot 1 in the Irving Minor Subdivision, in exchange for a 2.78-foot wide by 142.33-foot long strip of land along the south boundary of Lots 1 and 2 in the Irving Minor Subdivision; and

WHEREAS, a public hearing was held on this matter by the City Commission at 6:00 P.M. on the 29th day of October, 2012, in the City Commission Chambers, 316 North Park Avenue, in Helena, Montana.

# NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. That pursuant to §1-4-17 of the Helena City Code, a 396-square foot portion of the above-mentioned Mount Helena City Park property is hereby conveyed to Michael L. Gilleran and Amy D. Barrett in exchange for an equal-size portion of Lots 1 and 2 in the Irving Minor subdivision, subject to the following condition:

Brenda K. Elias and Brent A. Thompson; and Michael L. Gilleran and Amy D. Barrett will have prepared and pay

for an amended plat showing the new boundary lines of the Mount Helena City Park property and Lots 1 and 2 in the Irving Minor Subdivision, the advertising costs, title insurance (if requested by them), closing costs, and filing and recording fees.
