

RESOLUTIONS OF THE CITY OF HELENA, MONTANA

RESOLUTION NO. 20039

A RESOLUTION LEVYING AN ASSESSMENT UPON ALL PROPERTY IN SPECIAL STREET LIGHTING DISTRICTS TO DEFRAY THE COST OF INSTALLING AND MAINTAINING IMPROVEMENTS IN SAID DISTRICTS FOR FISCAL YEAR 2014

WHEREAS, the City Commission of the City of Helena, Montana, has created Special Improvement Districts for the purpose of providing lighting; and

WHEREAS, the lots or parcels of land in said Special Street Lighting Districts are to be assessed to defray the cost of installing and maintaining the said improvements, each lot or parcel of land in each district is to be assessed for that part of the whole cost which its area bears to the area of the entire district, exclusive of streets, alleys, and public places; and

WHEREAS, a list of all lots or parcels of land assessed, with the name of the owner thereof, if known, description of the lots or parcels of land and the amount levied thereon set opposite, is maintained by the Department of Administrative Services for the City of Helena; and

WHEREAS, a public hearing was held on this resolution on the 19th day of August, 2013, at 6:00 p.m. on the Commission Chambers in the City-County Building at 316 North Park Avenue in Helena, Montana.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. The City Commission hereby levies an assessment upon all lots or parcels of land in the Special Street Lighting Districts to defray the cost of installing and maintaining said improvements for fiscal year 2014.
