### **A RESOLUTION OF INTENTION TO CLOSE THE FULL WIDTH OF A PORTION OF THE EAST-WEST ALLEY RIGHT-OF-WAY BETWEEN OLIVE STREET AND HAMILTON STREET IN THE WASHINGTON PLACE SUBDIVISION IN THE CITY OF HELENA, MONTANA**

**WHEREAS, Mike Menahan and Stacy Tureck,** the owners of one of the properties adjacent to the following-described property in the City of Helena, Montana, have petitioned for the closure of a portion of the alley right-of-way between Olive Street and Hamilton Street between Lots 8-11 and 13-16 in Block 1 of the Washington Place Subdivision in the City of Helena, County of Lewis and Clark, State of Montana, more particularly described as follows:

The 10-foot wide east-west alley right-of-way between Lots 8-11 and 13-16 in Block 1 of the Washington Place Subdivision in the City of Helena, Lewis and Clark County, Montana

The attached map shows the proposed vacation.

**WHEREAS,** it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof that said alley right-of-way in the Washington Place Subdivision be closed.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 1.** It is the intention of the Helena City Commission that the alley right-of-way between Lots 8-11 and 13-16 in Block 1 in the Washington Place Subdivision in the City of Helena, County

of Lewis and Clark, Montana, more particularly described above, be closed. The Commission hereby directs the City Manager or his designee to serve notice of this resolution of intention upon affected owners of property abutting the portion of right-of-way affected by this proposed vacation, and directs the Clerk of the Commission to cause a notice to be published twice, at least six (6) days apart, in The Independent Record, a daily newspaper published in Helena, Montana, as provided by §7-14-4114, MCA. The notice shall state the time and place for hearing objections, and that expressions of approval or disapproval will be received in writing in the office of the Clerk of the Commission prior to the hearing thereon.

**Section 2.** A public hearing on the closure of said right-of-way shall be held before the Helena City Commission in its chambers at 316 North Park Avenue in Helena, Montana, at the call of the City Manager.
