## **RESOLUTION NO. 20132**

### **A RESOLUTION OF INTENTION TO AMEND RESOLUTIONS NOS. 9646 AND NO. 20071 WHICH ESTABLISHED A TYPE B RESIDENTIAL PARKING ZONE FOR CERTAIN STREETS IN THE CITY OF HELENA**

**WHEREAS**, the City Commission adopted Resolution No. 9646 on August 6, 1984, establishing a Type B Residential Parking Zone for certain streets bordered by Olive Street on the west, Ming Place on the south, Benton Avenue on the east (including the eastern side of Benton abutted by residences from Clarke Street to Edwards Street) and Clarke Street on the north; and

**WHEREAS**, on July 22, 2002, the City Commission amended Resolution No. 9646 by Resolution No. 11785 and removed a portion of Clarke Street and Benton Avenue adjacent to 303 Clarke Street from the parking zone; and

**WHEREAS**, on February 24, 2014, the Helena City Commission established, by Resolution 20071, a consolidated listing of all previously created and designated Residential Parking Districts, and further established certain criteria to be used in reviewing and processing any new petitions for the creation of Residential Parking Districts; and

**WHEREAS**, Resolution 20071 also directed City staff to ascertain the level of permit purchase activity in each Residential Parking District, and to bring any Districts where less than fifty

percent (50%) of the affected properties have each purchased at least one permit before the City Commission to consider the termination of the district;

**WHEREAS**, City staff has conducted that review and has identified a portion of the residential parking zone created by Resolution No. 9646 and amended by Resolution No. 11785 as meeting that criteria; and

**WHEREAS**, property owners in those portions of this residential parking zone have been notified that the district in which their property is located is now being brought before the City Commission for consideration of its removal.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 1.** It is the intention of the Helena City Commission to amend Resolution No. 9646 by removing the following rights-of-way from the Type B residential parking zone established by Resolution No. 9646:

**A.** Clark Street on the south side from the east right-of-way of Hamilton Street to the west property line of 303 Clarke Street, said point being west 65.4 feet more or less from the west right-of-way of Benton Avenue; and

**B.** Olive Street on the west side from the south line of the east-west alley south of Lots 13-17 in the Washington Place Subdivision to the north right-of-way line of Ming Place; and

**C.** Olive Street on the east side from the south right-of-way line of Clarke Street to the north right-of-way line of Edwards Street; and

**D.** Edwards Street on the north side from the west right-of-way of Benton Avenue to the east right-of-way of Olive Street.

**Section 2.** The right-of-way remaining in the Type B residential parking zone established by Resolution No. 9646 is as follows:

**A.** Benton Avenue on the west side from the south property line of 303 Clarke Street, said point being 76.5 feet more or less from the south right-of-way of Clarke Street, to the north right-of-way of Edwards Street; and

**B.** Benton Avenue on the eastside from the south line of the east-west alley south of Parcel 64 in Block 12 of the Helena Townsite to the intersection of the southerly projection of the south right-of-way of Edwards Street and the east right-of-way Benton Avenue.

**Section 3.** The Commission will consider the proposed amendment of Resolution No. 9646 that established a Type B residential parking zone at a regular meeting upon the call of the City Manager, in the City Commission Chambers at 316 North Park Avenue, in Helena, Montana, at which time public comment will be requested and heard.
