## **RESOLUTION NO. 20133**

### **A RESOLUTION OF INTENTION TO AMEND RESOLUTION NO. 20071 WHICH ESTABLISHED A CONSOLIDATED LISTING OF ALL CURRENT RESIDENTIAL PARKING DISTRICTS IN THE CITY OF HELENA**

**WHEREAS**, on February 24, 2014, the Helena City Commission established, by Resolution 20071, a consolidated listing of all previously created and designated Residential Parking Districts, and further established certain criteria to be used in reviewing and processing any new petitions for the creation of Residential Parking Districts; and

**WHEREAS**, the City Commission is currently considering termination of various residential parking districts pursuant to the criteria set forth in Resolution No. 20071; and

**WHEREAS**, the City Commission is also considering amending Resolution No. 9646 which established a Type B Residential Parking Zone for certain streets bordered by Olive Street on the west, Ming Place on the south, Benton Avenue on the east (including the eastern side of Benton abutted by residences from Clarke Street to Edwards Street) and Clarke Street on the north; and

**WHEREAS**, as a result of the actions terminating various residential parking districts and amending one residential parking district, it is necessary to update the consolidated list of existing residential parking districts established by Resolution

**Section 2.** The Commission will consider the proposed amendment of Resolution No. 20071 at a regular meeting upon the call of the City Manager in the City Commission Chambers at 316 North Park Avenue, in Helena, Montana, at which time public comment will be requested and heard.
