RESOLUTION NO. 20142

A RESOLUTION ANNEXING BLOCK LOTS 3-5 IN BLOCK 145 OF THE BASSETT-BRADFORD ADDITION, AND THE ADJACENT PORTIONS OF HAUSER BOULEVARD, GLENDALE STREET, AND THE ALLEY RIGHT-OF-WAY IN BLOCK 145 OF THE BARRETT-BRADFORD ADDITION, ALL LOCATED IN LEWIS AND CLARK COUNTY, INTO THE CITY OF HELENA, MONTANA

WHEREAS, Jay and Sandra Whitney, the legal owners of Lots 3-5 in Block 145 in the Barrett-Bradford Addition, in Lewis and Clark County, Montana, generally located east of Glendale Street and north of Hauser Boulevard, which property is currently located partially in and partially adjacent to the existing City limits, has requested that the City of Helena annex said property; and

WHEREAS, the City of Helena desires to annex said property and the adjacent rights-of-way under the provisions of Montana law;

WHEREAS, the City Commission established conditions for annexation by Resolution No. 20135 on October 20, 2014; and

WHEREAS, the conditions of annexation associated with this property have been met.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA, AS FOLLOWS:

Section 1. The Helena City Commission hereby annexes Lots 3-5 in Block 145 in the Barrett-Bradford Addition, and the adjacent portions of Hauser Boulevard, Glendale Street, and the alley right-of-way in Block 145 of the Barrett-Bradford Addition, which



property is currently located partially in and adjacent to the existing City limits.

Section 2. The boundaries of the City of Helena are hereby extended to include the above-described property.

Section 3. The Clerk of the Commission shall certify, under seal of the City of Helena, the Resolution which shall be filed with the Clerk and Recorder of Lewis and Clark County, and thereafter said annexed property shall be a part of the City of Helena and the City of Helena shall have the power to pass all necessary ordinances pertaining thereto.
