**A RESOLUTION OF INTENTION TO AMEND RESOLUTION NO. 20138
THAT AMENDED RESOLUTION NO. 20071
WHICH ESTABLISHED A CONSOLIDATED LISTING OF ALL CURRENT
RESIDENTIAL PARKING DISTRICTS IN THE CITY OF HELENA**

WHEREAS, on February 24, 2014, by Resolution No. 20071, the Helena City Commission established a consolidated listing of all previously created and designated Residential Parking Districts, and further established certain criteria to be used in reviewing and processing any new petitions for the creation of Residential Parking Districts; and

WHEREAS, on November 10, 2014, by Resolution No. 20138, amended Resolution No. 20071 to reflect the amendment of and termination of various previously established residential parking districts; and

WHEREAS, the City Commission is currently considering termination of a Type B residential parking district pursuant to the criteria set forth in Resolution No. 20071; and

WHEREAS, the City Commission is also considering repealing Resolution No. 10812 which established a Type B Residential Parking Zone for the 1100 block of 12th Avenue; and

WHEREAS, as a result of this action terminating the above residential parking district, it is necessary to update the consolidated list of existing residential parking districts

established by Resolution No. 20071 and amended by Resolution No. 20138.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. It is the intention of the Helena City Commission to amend Resolution No. 20138 as shown on the attached Exhibit "A" to reflect the termination of the Type B residential parking district created by Resolution 10812 for the 1100 block of 12th Avenue.

Section 2. The Helena City Commission will hold a public hearing on this matter in the Commission Chambers at 316 North Park Avenue in Helena, Montana, at 6:00 P.M. on the 4th day of December, 2017, at which time and place the Commission will hear objections to the final adoption of a resolution amending Resolution No. 20138.
