RESOLUTION NO. 20510

A RESOLUTION REPEALING RESOLUTION NO. 11577 APPOINTING THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT BOARD OF TRUSTEES AS THE HELENA PARKING COMMISSION AND AMENDING SECTION 3 OF RESOLUTION NO. 10295 TO REQUIRE THAT ONE MEMBER OF THE HELENA PARKING COMMISSION MUST ALSO SERVE ON THE DOWNTOWN BUSINESS IMPROVEMENT DISTRICT BOARD OF TRUSTEES

WHEREAS, on July 15, 1991, the Helena City Commission passed Resolution No. 10295 establishing a separate Helena Parking Commission ("HPC") pursuant to the provision of § 7-14-4603, MCA;

WHEREAS, on October 16, 2000, the City Commission passed Resolution No. 11577 appointing the Downtown Business Improvement District ("BID") Board of Trustees as the HPC;

WHEREAS, the City Commission now wishes to repeal Resolution No. 11577 so that the BID and the HPC are governed by two separate boards;

WHEREAS, the City Commission also wishes to ensure that the BID will continue to be able to provide input into the affairs of the HPC by requiring that one member of the HPC also serve on the BID board of trustees; and

WHEREAS, it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof, that Resolution No. 11577 be repealed and Resolution No. 10295 be amended in

accordance with the findings stated above.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA;

Section 1. Resolution No. 11577 is hereby repealed.

Section 2. Section 3 of Resolution No. 10295 is amended to read as follows:

That said Parking Commission shall be composed of seven (7) electors of the City of Helena, the members of the Commission shall represent a broad scope of interested parties, be separate from and not constituted by the members of the Helena City Commission, and shall be appointed as follows:

Advertise and appoint the Parking Commission at large with no set slots. The qualifications and diversity of the members shall be determined by the City Commission except that one (1) member of the Parking Commission shall also serve on the Downtown Business Improvement District Board of Trustees.

Section 3. Effective July 1, 2019.
