## RESOLUTION NO. 20516

### A RESOLUTION OF INTENTION TO VACATE A PORTION OF HOWIE STREET ADJACENT TO LOT 9 AND THE WEST 25 FEET OF LOTS 11 THROUGH 14 IN BLOCK 4 OF THE HELENA TOWNSITE 1869 IN THE CITY OF HELENA, MONTANA

**WHEREAS,** Kathryn Wright, the owner of the property adjacent to the following described public right-of-way property in the City of Helena, Montana, has petitioned for the vacation of the eastern portion of Howie Street adjacent to Lot 9 and the west 25 feet of Lots 11 through 14 in Block 4 of the Helena Townsite 1869, as shown on Certificate of Survey No. 3065974 in Helena, Lewis and Clark County, Montana; and

**WHEREAS,** it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof, that the eastern unused portion of Howie Street adjacent to Lot 9 and the west 25 feet of Lots 11 through 14 in Block 4 of the Helena Townsite 1869, be vacated.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 1.** It is the intention of the Helena City Commission that the eastern 2,548 square foot portion of Howie Street adjacent to Lot 9 and the west 25 feet of Lots 11 through 14 in Block 4 of the Helena Townsite 1869, Helena, Lewis and

Clark County, Montana, as shown on the attached Exhibit "A" be vacated. The Commission hereby directs the City Manager or her designee to serve notice of this resolution of intention upon affected owners of property abutting the portion of the right-of-way affected by this proposed vacation, and directs the Clerk of the Commission to cause a notice to be published once in The Independent Record, a daily newspaper published in Helena, Montana, as provided by §7-3-4448, MCA. The notice shall state the time and place for hearing objections, and that expressions of approval or disapproval will be received in writing in the office of the Clerk of the Commission prior to the hearing thereon.

**Section 2.** A public hearing on this vacation request shall be held before the Helena City Commission in its chambers at 316 North Park Avenue in Helena, Montana, on the 6<sup>th</sup> day of May, 2019 at 6:00 p.m.
