RESOLUTION NO. 20632

A RESOLUTION OF INTENTION TO AMEND THE REVISED FISCAL YEAR 2021 BUDGET FOR THE CITY OF HELENA, MONTANA BY AMENDING RESOLUTION NO. 20609 AND TRANSFERRING \$299,627.38 (as of 11/10/2020) FROM THE COMMUNITY RENEWAL FUND TO THE AFFORDABLE HOUSING TRUST FUND

WHEREAS, by Resolution 20609 adopted June 29, 2020, the City of Helena adopted the revised budget for fiscal year 2021;

WHEREAS, Section 7-6-4006(4), MCA, permits the City Commission to amend the budget;

WHEREAS, Section 7-6-4006(4), MCA, requires a public hearing before any amendment can be approved by the City Commission;

WHEREAS, by Resolution 20630, adopted November 9, 2020, the City of Helena created the Affordable Housing Trust Fund;

WHEREAS, KCAP Park and the property commonly referred to as the "Old Bus Depot" were sold by the City of Helena in FY 2020, the proceeds of which were placed into a special revenue fund designated for Community Renewal efforts by the Commission and in accordance with guidelines established by city staff;

WHEREAS, the Commission has expressed an interest in transferring the KCAP Park and "Old Bus Depot" proceeds from the Community Renewal Fund to the Affordable Housing Trust Fund as an initial funding source; and

WHEREAS, it appears to be in the best interests of the City of Helena and the inhabitants thereof that the Helena City Commission make the budget amendment as identified below.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. The Helena City Commission intends to amend the revised Fiscal Year 2021 budget by amending Resolution No. 20609 and authorizing the transfer of \$299,627.38 (as of 11/10/20) from the Community Renewal Fund (#228) to the Affordable Housing Trust Fund (#229)

Section 2. A public hearing on this Resolution of Intention will be held on the **21st day of December 2020**, via Zoom Meeting at webinar ID: <https://zoom.us/j/91008083209> at **6:00 p.m.**, at which time the Commission will hear objections to the final adoption of this resolution.

Section 3. The City Clerk is hereby directed to publish the notice of the above-referenced public hearing on the proposed budget amendment in accordance with state law and city ordinances, and to make a copy of the notice and this resolution available for public inspection in the Clerk's office.
