

RESOLUTIONS OF THE CITY OF HELENA, MONTANA

RESOLUTION NO. 20633

A RESOLUTION OF INTENTION TO REDUCE THE MONTHLY WASTEWATER SERVICE LINE REPLACEMENT LOAN PROGRAM CHARGE AND ELIMINATE THE MONTHLY WATER AND WASTEWATER CHARGES THAT FUND THE RESIDENTIAL WATER AND WASTEWATER SERVICE LINE REPLACEMENT LOAN PROGRAM ON JUNE 30, 2030, AND AMEND RESOLUTION NO. 20488

WHEREAS, the City Commission passed Resolution No. 20488 on August 27, 2018, which re-established various charges and fees previously established by the City of Helena;

WHEREAS, the City Commission passed Resolution No. 20495 on October 29, 2018, which among other fees and charges, established a monthly charge to fund the Residential Water and Wastewater Service Line Replacement Program ("Program") by amending Resolution No. 20488;

WHEREAS, it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof, that the monthly Program charge per wastewater account be reduced and the monthly Program charge per water & wastewater account be eliminated on June 30, 2030.

BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. It is the intention of the Helena City Commission to reduce the monthly wastewater Program charge from

\$6.47 to \$2.50.

Section 2. It is also the intention of the Helena City Commission to eliminate the Program charges that fund the residential water and wastewater service line replacement loan on June 30, 2030.

Section 3. It is also the intention of the Helena City Commission to amend Exhibit "A" to Resolution No. 20488 to reflect the above changes. All other charges and fees established by Resolution No. 20488 are intended to remain in effect as previously established.
