RESOLUTION NO. 20103

A RESOLUTION OF INTENTION TO INCREASE RATES FOR ALL CUSTOMERS OF THE CITY OF HELENA WASTEWATER SYSTEM

WHEREAS, wastewater system users are charged a base rate, a per unit rate, and a surcharge for use of the wastewater collection system as required by §6-3-2 of the Helena City Code; and

WHEREAS, the Helena City Commission last raised wastewater rates in November of 2013; and

WHEREAS, rate increases are necessary to adjust for inflation, cost of service, provide for necessary capital improvements, and meet bonded debt coverage; and

WHEREAS, it appears to be in the best interests of the City of Helena and the inhabitants thereof that the rates and charges imposed upon wastewater customers be increased; and

WHEREAS, It is the intention of the Helena City Commission to consider increasing wastewater base, usage, and surcharge rates imposed upon all wastewater customers by an amount up to 2.5% for each rate.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. The new proposed rates, reflecting a maximum increase of up to 2.5% are shown below:

Wastewater Base	\$ 4.96 phpm ¹	\$ 5.08 phpm ¹
Wastewater Usage	\$ 2.20/unit ²	\$ 2.26/unit ²
Wastewater Surcharge Base	\$ 1.46 phpm ¹	\$ 1.50 phpm ¹
Wastewater Surcharge Usage	\$ 0.41/unit ²	\$ 0.42/unit ²
