| Background | The Bipartisan Infrastructure Law (BIL) continues the Transportation Alternatives (TA) set-aside from the Surface Transportation Block Grant (STBG) program. Eligible applicants and projects for these set-aside funds include all capital improvement and pavement preservation projects that were previously eligible under the Transportation Alternatives Program established by the Moving Ahead for Progress in the 21st Century Act (MAP-21). This encompasses a variety of smaller-scale transportation projects, such as pedestrian and bicycle facilities, recreational trails, safe routes to school projects, community improvements like historic preservation and vegetation management, and environmental mitigation related to stormwater and habitat connectivity. Notably, non-profits are now eligible to apply, with project requests needing to go through the Metropolitan Planning Organization (MPO). The BIL allows MPOs to administer their own competitive application processes, with approval and oversight from the Montana Department of Transportation (MDT). Applications can come from entities within the MPO as well as from the MPO itself, particularly when there is funding that is not population-based. All submitted projects must meet federal and state eligibility guidelines and identify a local, federal, or state sponsoring agency. Private individuals and organizations may recommend a project provided it is sponsored by the relevant governmental agency. Examples of sponsoring agencies may include, but are not limited to, the City of Helena, the City of East Helena, Lewis and Clark County, and the Montana Department of Transportation. |
