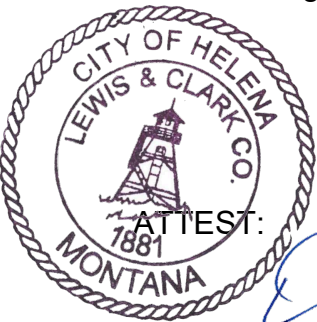
Public Communications
