### RESOLUTION NO. 20254

A RESOLUTION ESTABLISHING A TYPE B RESIDENTIAL PARKING DISTRICT FOR THE 800 BLOCK OF JACKSON STREET AND HALF OF THE BLOCK ON THE NORTH SIDE OF 14<sup>th</sup> STREET FROM JACKSON STREET EAST TO THE ALLEY, ALL IN THE CITY OF HELENA

WHEREAS, §8-14-7 of the Helena City Code allows creation of Residential Parking Districts wherein parking in residential zones limits non-resident parking to 2-hour periods or is restricted solely to the residents of the zone and their authorized guests; and

WHEREAS, pursuant to the aforementioned Code section, the Helena City Commission may officially designate certain residential parking areas as either Type A Residential Parking Districts which limit non-resident parking in said zones to 2-hour periods, or Type B Residential Parking Districts which limit parking in said zones solely to residents bordering the streets in the zone and to their authorized guests; and

WHEREAS, it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof that a Type B Residential Parking District be established for the 800 block of Jackson Street and half of the block on the north side of 14<sup>th</sup> Street from Jackson Street east to the alley adjacent to the property at 801 North Jackson Street in Helena, Montana; and

WHEREAS, a public hearing was held by the City Commission on this matter at 6:00 p.m. on the  $6^{th}$  day of June, 2016, in the City Commission Chambers, 316 North Park Avenue, in Helena, Montana.

NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. That the Helena City Commission hereby establishes a Type B Residential Parking District for the 800 block of Jackson Street and half of the block on the north side of 14<sup>th</sup> Street from Jackson Street east to the alley adjacent to the property at 801 North Jackson Street, but excluding Lots 7-8 in Block 575 of the Central Addition No. 2, with property addresses of 830 and 836 Jackson Street, 24 hours per day, Sunday through Saturday, as shown on Exhibit "A" attached hereto.

Section 2. The effect of this designation limits parking on the aforementioned street solely to residents and their authorized guests on the days and during the times stated above.

**Section 3.** The owner of Lot 1 in Block 575 of the Central Addition No. 2 at the northwestern corner of East  $14^{\rm th}$

Street and Jackson Street is entitled to the same number of residential parking district permits and temporary guest parking permits as allowed by law for any other residence in the district.
