## RESOLUTION NO. 20328

### A RESOLUTION OF INTENTION TO ESTABLISH FEES TO BE CHARGED FOR THE LAST CHANCE SPLASH WATERPARK AND POOL

**WHEREAS,** the City of Helena operates the Last Chance Splash Waterpark and Pool facility, which includes the operation of a waterpark and concession building; and

**WHEREAS,** Resolution 20153 previously established user fees for the Last Chance Splash Waterpark and Pool; and

**WHEREAS,** City staff recommends simplifying the various fee categories and increasing the fees charged for certain programs and services to support continued cost recovery; and

**WHEREAS,** it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof, that the Helena City Commission hold a public hearing on the proposed fees for the Last Chance Splash Waterpark and Pool.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 2.** Punch cards are transferable and are valid for 10 visits per season. Unused punches on punch cards will not be extended to the next season. No refunds will be given for lost or stolen punch cards.

**Section 3.** Season passes are not transferable and are good for unlimited visits during one swim season. Lost season passes may be replaced with proof of purchase.

**Section 4.** When the facility must be closed due to weather or health issues, One Dollar (\$1.00) vouchers that can be used towards the price of a subsequent entry may be issued to those individuals who have paid to use the Last Chance Splash Waterpark and Pool facility and are present within the facility when it is closed due to weather or health issues. These vouchers are valid only during the same swim season.

**Section 5.** The following definitions apply for purposes of this resolution only:

"Youth" is a person 4 to 12 years of age.

"Adult" is a person 13 to 64 years of age.

"Senior" is a person 65 years of age or older.

"Family" is up to two adults and their dependent children under 18 years of age who reside at the same address.

"Private Swim Lessons" are one or two participants and one instructor and subject to any fees established in this resolution.

"Resident" is any person who resides within the city limits of the City of Helena.

"Non-resident" is any person who does not reside within the city limits of the City of Helena.

**Section 6.** It is the intention that Resolution 20153 be superseded.

**Section 7.** A public hearing on these proposed user fees for the Last Chance Splash Waterpark and Pool facility in Memorial Park shall be held before the Helena City Commission in its chambers at 316 North Park Avenue in Helena, Montana, on **the 13<sup>th</sup> day of March, 2017, at 6:00 p.m.**
