

# RESOLUTIONS OF THE CITY OF HELENA, MONTANA

## RESOLUTION NO. 20416

### A RESOLUTION OF INTENTION TO REPEAL RESOLUTION NO. 10812 TO TERMINATE A TYPE B RESIDENTIAL PARKING DISTRICT

**WHEREAS**, the Helena City Commission authorized, through Helena City Code §8-14-7, the creation and designation of Residential Parking Districts wherein non-resident parking is either limited to 2-hour periods (Type A) or is restricted solely to the residents of the district and their authorized guests (Type B); and

**WHEREAS**, the Helena City Commission has taken action over time to create and designate numerous Residential Parking Districts throughout the City; and

**WHEREAS**, on September 19, 1994, by Resolution No. 10812, the Helena City Commission established a Type B Residential Parking District for the 1100 block of 12<sup>th</sup> Avenue in the City of Helena; and

**WHEREAS**, Resolution No. 20071 established criteria to be used in reviewing petitions for the creation of residential parking districts; and

**WHEREAS**, the Type B Residential Parking District for the 1100 block of 12<sup>th</sup> Avenue affects only two properties and both

have adequate off-street parking available so this district no longer meets criteria 2(C) and (D) as set forth in Resolution No. 20071; and

**WHEREAS,** property owners in that Residential Parking District have been notified that the district in which their properties are located is now being brought before the City Commission for consideration of termination of that district.

**NOW, THEREFORE, BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:**

**Section 1.** It is the intention of the Helena City Commission to repeal Resolution No. 10812 to terminate the Type B Residential Parking District for the 1100 block of 12<sup>th</sup> Avenue.

**Section 2.** The Helena City Commission will hold a public hearing on this matter in the Commission Chambers at 316 North Park Avenue in Helena, Montana, at 6:00 P.M. on the 4<sup>th</sup> day of December, 2017, at which time and place the Commission will hear objections to the final adoption of a resolution terminating the Type B Residential Parking District for the 1100 Block of 12<sup>th</sup> Avenue.
