

RESOLUTIONS OF THE CITY OF HELENA, MONTANA

RESOLUTION NO. 20789

A RESOLUTION RESCINDING RESOLUTION NOS. 20495 AND 20639 TO ELIMINATE THE MONTHLY WATER AND WASTEWATER CHARGES THAT FUND THE RESIDENTIAL WATER AND WASTEWATER SERVICE LINE REPLACEMENT LOAN PROGRAM, AND AMENDING RESOLUTION NO. 20488.

WHEREAS, the City Commission passed Resolution No. 20488 on August 27, 2018, which re-established various charges and fees previously established by the City of Helena;

WHEREAS, the City Commission passed Resolution No. 20495 on October 29, 2018, which among other fees and charges, established a monthly charge to fund the Residential Water and Wastewater Service Line Replacement Program ("Program") by amending Resolution No. 20488;

WHEREAS, the City Commission passed Resolution No. 20639 reducing the monthly wastewater service line replacement loan program charge and providing a sunset date to eliminate the monthly water and wastewater charges that funded the residential water and wastewater service line replacement loan programs on June 30, 2030;

WHEREAS, the City Commission has found that the Residential Water and wastewater service line replacement loan program has been underutilized and as such, monies collected for the purpose of this program are not being used in the capacity anticipated;

WHEREAS, it appears to be in the best interests of the City of Helena, Montana, and the inhabitants thereof, that the monthly Program charges to fund the Residential Water and Wastewater Service line Replacement Program be eliminated; and

WHEREAS, a public hearing on the fees for the Program was held on December 19, 2022, via Zoom Meeting at webinar ID: _____ at 6:00 p.m.

NOW BE IT RESOLVED BY THE COMMISSION OF THE CITY OF HELENA, MONTANA:

Section 1. That the Helena City Commission hereby rescinds Resolution No. 20495 and 20639 to eliminate the charges that fund the residential water and wastewater service line replacement loan effective January 2023.

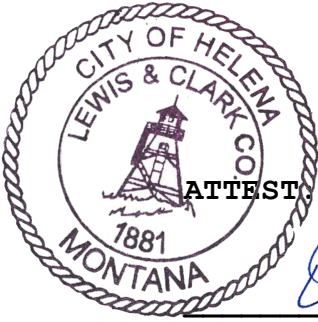
