## **RIDERSHIP RULES**

All passengers are required to obey reasonable request from the driver and expected to abide by the following rules, anyone who fails to comply shall be refused service and directed by the Driver/Transit Staff member to exit the bus or transit facility immediately, or be suspended from riding the bus, and may be prosecuted to the full extent of applicable laws. Therefore, Please refrain from the following acts and behaviors which include but are not limited to the following:

- 1. Payment of correct Bus Fare is required upon entry of the Bus. "NO FARE= NORIDE"
- 2. Change Drivers cannot make change for passenger fares or bus pass purchases.
- 3. Unlimited Bus Passes are valid for the purchaser only and are non-transferable/usable by other passengers.
- 4. Only Service Animals are allowed on the bus and must be controlled at all times.
- 5. No pets or comfort animals allowed on transit vehicles or in transit facility unless secured in a pet carrier at all times.
- 6. No Passengers allowed in front-cab seat of any vehicle operated by Capital Transit.
- 7. No unnecessary/distracting conversations or Interfering with the safe operation of transit vehicles while in motion.
- 8. Roller skates, skateboards, and rollerblades must be carried onboard.
- 9. Baby strollers must not be occupied and must be folded away, and child/toddler or infant must be secured in an appropriate carrier/car seat and seatbelt.
- 10. No placing your feet on seats or seat backs or lying down on the seats.
- 11. No bicycles, oversized packages, flammable liquids, car batteries, fireworks, explosive materials, or weapons of any kind are prohibited on buses.
- 12. Carry-on items are limited to what you can carry and must be kept under your control, by using your lap, available floor area under/in front of your seat, your items cannot be placed on empty seats.
- 13. Any pet carrier, service animal, strollers or other items must be kept out of the aisles, and aisles must be clear at all times.
- 14. Capital Transit is not responsible for lost or stolen items.
- 15. No profanity, offensive harassing, lewd, loud, disruptive, drunk, disorderly, intimidating language or behaviors that threaten/endanger staff and passenger; or impedes transit vehicles or passenger movements.
- 16. No smoking or expulsion of the residue of any tobacco product including vapor (e-cigarette, vaporizing electronic system or otherwise) and chewing tobacco on a bus or within 50 feet of a Capital Transit Facility structure.
- 17. No littering or spitting in transit vehicles or on transit property.
- 18. No eating of food items allowed on the bus.
- 19. Only closed containers of non-alcoholic consumable liquids are allowed on a bus, paper cups with lids and straws (typical fountain drinks) are not considered a closed container.
- 20. No consumption of alcoholic beverages inclusive of non/low alcoholic beverages or open alcoholic containers are not allowed on bus or at the Capital Transit facility at any time.
- 21. No destroying or vandalizing vehicles, facility, property, signs, notices or announcements.
- 22. No urinating or defecating on transit vehicles or on transit facility property except in restrooms.
- 23. No camping in or on transit property or storing personal property.
- 24. No loitering without intent to utilize transit services.
- 25. No bringing onto transit property or vehicles, odors and substances which unreasonably disturb others or interfere with their use of the transit system, whether such odors or substances are from one's person, clothes, articles, accompanying animal or any other source.
